

STUDENT MOBILE PHONES

PURPOSE

To explain to our school community the Department's and Rowellyn Park Primary School's policy requirements and expectations relating to students using mobile phones and other personal mobile devices during school hours.

SCOPE

This policy applies to:

1. All students at Rowellyn Park Primary School and,
2. Students' personal mobile phones and other personal mobile devices brought onto school premises during school hours, including recess and lunchtime.

DEFINITIONS

A **mobile phone** is a telephone or any device with similar functionality to a mobile phone, such as a smartwatch, with access to a cellular (telecommunication) system, with or without a physical connection to a network.

POLICY

Rowellyn Park Primary School understands that students may bring a personal mobile phone to school, particularly if they are travelling independently to and from school.

At Rowellyn Park Primary School:

- Students who choose to bring mobile phones to school must have them switched off and securely stored during school hours
- Students who chose to bring smart watches to school must be switched to airplane mode and disconnected from the host mobile phone during school hours
- Exceptions to this policy may be applied if certain conditions are met (see below for further information)
- When emergencies occur, parents or carers should reach their child by calling the school's office.

Personal mobile phone use

In accordance with the Department's [Mobile Phones Policy](#) issued by the Minister for Education, personal mobile phones must not be used at Rowellyn Park Primary School during school hours, including lunchtime and recess, unless an exception has been granted.

Where a student has been granted an exception, the student must use their mobile phone for the purpose for which the exception was granted, and in a safe, ethical and responsible manner.

Secure storage

Mobile phones owned by students at Rowellyn Park Primary School are considered valuable items and are brought to school at the owner's (student's or parent/carer's) risk. Students are encouraged not to bring a mobile phone to school unless there is a compelling reason to do so. Please note that Rowellyn Park Primary School does not have accident insurance for accidental property damage or theft. Students and their parents/carers are encouraged to

obtain appropriate insurance for valuable items. Refer to the school's Personal Property Policy and the Department's [Personal Goods policy](#).

Where students bring a mobile phone to school, Rowellyn Park Primary School will provide secure storage in the Administration Office. Secure storage is storage that cannot be readily accessed by those without permission to do so. At Rowellyn Park Primary School students are required to sign their phones into the school office upon their arrival at school, and collect them at the end of the day.

Enforcement

Students who use their personal mobile phones inappropriately at Rowellyn Park Primary School may be issued with consequences consistent with our school's existing student engagement policies, code of conduct and behaviour management policies.

At Rowellyn Park Primary School inappropriate use of mobile phones is **any use during school hours**, unless an exception has been granted; and particularly use of a mobile phone:

- in any way that disrupts the learning of others
- to send inappropriate, harassing or threatening messages or phone calls
- to engage in inappropriate social media use including cyber bullying
- to capture video or images of people, including students, teachers and members of the school community without their permission
- to capture video or images in the school toilets, changing rooms, swimming pools and gyms
- during exams and assessments

Exceptions

Exceptions to the policy:

- may be applied during school hours if certain criteria are met, as outlined in the categories of exception below, specifically,
 - Health and wellbeing-related exceptions; and
 - Exceptions related to managing risk when students are offsite.
- can be granted by the principal, or by the teacher for that class, in accordance with the Department's [Mobile Phones Policy](#).

The three categories of exceptions allowed under the Department's [Mobile Phones Policy](#) are:

1. Learning-related exceptions

Specific exception	Documentation
For specific learning activities (class-based exception)	Unit of work, learning sequence
For students for whom a reasonable adjustment to a learning program is needed because of a disability or learning difficulty	Individual Learning Plan, Individual Education Plan

2. Health and wellbeing-related exceptions

Specific exception	Documentation
Students with a health condition	Student Health Support Plan

3. Exceptions related to managing risk when students are offsite

Specific exception	Documentation
When students are offsite (not on school grounds) and unsupervised with parental permission	Risk assessment planning documentation
Students with a dual enrolment or who need to undertake intercampus travel	Risk assessment planning documentation

Where an exception is granted, the student can only use the mobile phone for the purpose for which it was granted.

Camps, excursions and extracurricular activities

Rowellyn Park Primary School will provide students and their parents and carers with information about items that can or cannot be brought to camps, excursions, special activities and events, including personal mobile phones.

EXCLUSIONS

This policy does not apply to

- Out-of-school-hours events
- Travelling to and from school
